2025 Awards for Committee Excellence

PROGRAM OVERVIEW

The **Chairman's Challenge** is designed to celebrate exceptional committee-driven initiatives and highlight the outstanding content produced by Nicsa volunteers. Through this awards program, Nicsa will recognize content that exemplifies thought leadership, industry collaboration, and educational impact.

Each year, committees will have the opportunity to submit a piece of content (white paper, survey, blog, webinar, or other strategic output) for consideration.

Nicsa Leadership will select committees whose work exemplifies innovation, relevance, and industry impact.

Selected committees will be honored from the main stage during the Asset & Wealth Management Summit in November, receiving recognition among their industry peers. Selected content will be featured in a special edition of the Nicsa Connect Newsletter.

PURPOSE & GOALS

- Highlight valuable content that enhances education and engagement across the industry
- Recognize and celebrate the work of Nicsa committees and volunteers
- Incentivize innovation and collaboration across Nicsa's committees
- Strengthen visibility for committees and their volunteers within the broader Nicsa community.

SUBMISSION CRITERIA

All content submissions will be evaluated based on the following:

- **Relevance:** Addresses current trends, challenges, or innovations in the asset and wealth management industry.
- **Impact:** Demonstrates value to Nicsa members and/or to the broader industry.
- **Collaboration:** Reflects effective teamwork among committee members.
- **Best Practices:** Offers best practices guidelines or solutions to industry issues.

Submissions may comprise white papers, surveys, case studies, best practices guides, toolkits, roundtables, webinars, podcasts, blogs, etc.

For the 2025 awards, committees can submit content produced in 2024 or 2025 (*up until the September 5 deadline*).

SUBMISSION PROCESS

Committees will be asked to submit:

- Title and description of the content piece(s)
- Link or attachment to the content
- Brief statement (300 words or less) outlining the purpose and impact of the content

Submissions are due by: Friday, September 5

The expectation is that the co-chairs of each committee will be responsible for uploading the submission.

Winning committees will be notified in mid-October, in advance of the Summit, which is taking place November 10-12 in Boston this year.
